- Proposed projects that would exceed a numeric threshold contained in a question should result in the reviewing agency checking the box “Moderate to large impact may occur.”
- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.



1. Impacts on Land

While it is possible that future construction on the proposed subdivision lots may be located on slopes of 15% or greater, each lot will require the preparation of an Erosion and Sediment Control Plan, at a minimum. It's more likely that construction on the lots will result in the disturbance of more than one (1) acre. Therefore, a Storm Water Pollution Prevention Plan (SWPPP) will have to be prepared and coverage under the State Pollution Discharge Elimination System (SPDES) General Permit for Construction Activity will be required.

The SWPPP will address minimizing disturbance to the sites, vegetation removal and post construction stabilization and revegetation of disturbed areas.

The proposed five lot subdivision represents a reduction in density of at least two lots. By reducing residential density on site, the impact on land is reduced

2. Impacts on Geologic Features

There is an existing bluff along the entire frontage on Peconic Bay. No dwellings will be placed closer to the top edge of the bluff than 100 feet. No disturbance to the bluff will be permitted.

3. Impacts on Surface Water

Since the top of bluff is located landward of the upland edge of the tidal wetlands, the bluff setback provides a greater setback for the upland edge of tidal wetlands than is typically required in the Town's wetland regulations.

The Erosion and Sediment Control Plan or SWPPP will provide measures that reduce potential impacts on adjacent water bodies.

Since the subject parcel has frontage on Peconic Bay and contains tidal wetlands, the subdivision will require a Tidal Wetland Permit from the New York State Department of Environmental Conservation.

4. Impacts on Groundwater

The subject parcel is already improved with one single-family residence with a private well. The proposed subdivision will result in four additional single-family residences. There will be a total of five wells on the 16.142-acre site.

The reduction in density from seven lots to five lots reduces the demand for potable water accordingly.

Water supplies for the residences will be subject to approval by the Suffolk County Department of Health Services (SCDHS).

The proposed residences will have innovative/alternative nitrogen removal onsite wastewater treatment system (I/A OWTS) to handle wastewater. These systems will be subject to approval by the SCDHS.

5. Impacts on Flooding

The subdivision map shows FEMA Flood Zone Lines along the site's frontage on Peconic Bay. The required 100-foot bluff setback ensures that no residences will be constructed in flood hazard zones.

All stormwater runoff from impervious surfaces on site will be collected and recharged into the groundwater regime.

6. Impacts on Air

None.

7. Impacts on Plants and Animals

The NYSDEC has documented the summer occurrence of the Northern Long Eared Bat, a species listed as "endangered" by both NYS and US Fish & Wildlife Service, within 3 miles of the project location.

Based on the above, tree cutting activities between the dates of March 1 and November 30 are prohibited.

8. Impacts on Agricultural Resources

None.

9. Impacts on Aesthetic Resources

Conservation Easement of varying width, 53' -55'± are proposed along the property's frontage on Nostrand Parkway. These conservation easements, along with additional building setbacks proposed on the lots will preserve the scenic tree-lined vista along the roadway.

10. Impacts on Historic and Archeological Resources

None.

11. Impacts on Open Space and Recreation

None.

12. Impacts on Critical Environmental Areas

The subject parcel has frontage on Peconic Bay, a critical environmental area designated by Suffolk County.

Wetland and bluff setbacks and a reduction of residential density from seven lots to five lots will mitigate the potential impact on this resource.

13. Impacts on Transportation

The proposed subdivision will have minimal vehicle trip generation

14. Impacts on Energy

An increase in energy use associated with four additional single family residences can be expected.

15. Impact on Noise, Odor and Light

Upon completion of construction of the four additional single-family residences, the impact on noise should be minimal.

No impacts on odor is expected.

All proposed residences will have to comply with the lighting requirements that are established in Chapter 83: Lighting of the Code of the Town of Shelter Island, Section 83-4 Residential Areas.

As a result, all lighting must be fully shielded so as to minimize light extending across property boundaries. All exterior lighting shall be reduced to lighting essential to safety from midnight to dawn.

16. Impact on Human Health

None.

17. Consistency with Community Plans

The subject parcel is located in District AA (Residential), which requires a minimum lot area of 80,000 s.f. The purpose of this district is to provide low-density residential development in coastal areas.

By voluntarily reducing the number of permitted lots from seven to five the project sponsor has further lowered the density on the subject parcel. Even excluding the Conservation Easements, wetland areas and driveway access locations, the average lot size is approximately 121,130 s.f.

18. Consistency with Community Character

The reduced density residential subdivision is consistent with the Town's goal to provide low-density residential development.

The proposed 53'-55'+ Conservation Easements along the property's frontage on Nostrand Parkway, along with additional building setbacks from the edge of the Conservation Easement areas will help to preserve the existing natural woodland landscape along that portion of the roadway.
